The Board of Directors of WIIT S.p.A. has approved the financial report and the consolidated financial report at 31 December 2017

- Consolidated revenues equal to € 19.6 million (+27,5% compared to 31 December 2016)
- Consolidated adjusted EBITDA equal to € 8.5 million (+80% compared to 31 December 2016); Adjusted margin EBITDA 43% (31% 31 December 2016)
- Consolidated adjusted EBIT equal to € 5.4 million (+125% compared to 31 December 2016); Adjusted margin EBIT 28% (16% 31 December 2016)
- Net profit equal to € 3.1 million (+244% compared to 31 December 2016)
- Net financial debt: cash equal to € 7.9 million (compared to debt of € 8.9 million at 31 December 2016)
- Proposed dividend of Eur 0,83 p.s.

Milan, 29 March 2018 – The Board of Directors of WIIT S.p.A. ("WIIT" or the "Company"), one of the leading Italian players in the market of Cloud Computing services for businesses with a focus on the delivery of continuous Hybrid Cloud and Hosted Private Cloud services for critical applications, approved the Group's results at 31 December 2017.

Alessandro Cozzi, CEO of Wiit:

"We are particularly satisfied: Adjusted EBITDA and Adjusted EBIT were better than expected. This positive result, in terms of increased profitability, is due entirely to organic growth. We are confident for the current financial year that will also benefit from the major trade agreements signed in 2017".

Consolidated resulta t 31 December 2017

At 31 December 2017 WIIT recorded consolidated revenues equalling \leq 19.6 million (+27,5 compared to the \leq 15.3 million recorded at 31 December 2016).

The adjusted EBITDA was measured at € 8.5 million, this confirming a considerable growth trend (+80%) against the € 4.7 million at 31 December 2016, with a 43,3% incidence on revenues, higher than the 30.6% recorded at 31 December 2016. The Adjusted EBIT (net operating margin) was € 5.4 million (+125% better than 31 December 2016), and represented 28% of revenues – this value also being an improvement over the 16% recorded at 31 December 2016.



Equalling \leq 3.1 million, the net profit recorded a 244% increase (\leq 0.9 million at 31 December 2016).

Net financial debt improved by \leqslant 16.8 million, - \leqslant 8.9 million in debt at 31 December 2016 against \leqslant 7,9 milion in cash at 31 December 2017 and \leqslant 4.9 million in cash at 30 June 2017) – thanks also to the proceeds from the listing on the AIM Italia market, despite the impact of investments for a value of over \leqslant 7 million that characterized the year. The net financial position improved significantly, turning positively mainly as a result of the share capital increase carried out for the purposes of the Company's listing on the AIM Italia market, of the conversion of the convertible bonds issued, which was joined by a strong generation of cash deriving from operating activities in the second half of 2017.

Dividend

The Board of Directors resolved to propose to the Ordinary Shareholders' Meeting the distribution of a gross dividend equal to Euro 0.83 for each WIIT shares, according to the following schedule: dividend date May 7, 2018 (ex date), date of entitlement to receive the dividend May 8, 2018 (record date) and payment date of the dividend May 9, 2018 (payment date).

Call of the Ordinary Shareholders' Meeting

The Board of Directors resolved to convene the Ordinary Shareholders' Meeting of the WIIT Shareholders at the Fondazione Stelline, in Milan, Corso Magenta no. 61, on April 20, 2018, at 10:00 on first call, and on April 21, 2018, the same place and time, on second call, to discuss and resolve on the following item on the agenda:

Approval of the financial statements for the year ended December 31, 2017; related and consequent resolutions.

The draft annual financial statements with the related reports and the consolidated financial statements for the year ended December 31, 2017, subject to statutory auditing by the company Deloitte & Touche SpA, will be made available at the registered office and on the website of the Company (http://www.wiitgroup.com/), within the Investor Relations section, in terms of law and regulation.
