Change in share capital: allocation of WIIT shares following the vesting of the Units assigned to the beneficiaries of the "WIIT 2016-2018 Performance Share Plan"

Milan, 31 December 2018 – WIIT S.p.A. ("**WIIT**" or the "**Company**"), one of the leading Italian players in the market of Cloud Computing services for businesses with a focus on the delivery of continuous Hybrid Cloud and Hosted Private Cloud services for critical applications, announces the new share capital following the vesting of the Units assigned to the beneficiaries of the incentive plan "Performance Share Plan WIIT 2016 - 2018". Following the vesting of the Units, the beneficiaries were assigned newly issued WIIT shares for the capital increase approved by the Company's extraordinary shareholders' meeting on 20 July 2016.

In particular, it should be noted that on 31 December the fourth tranche of the aforementioned incentive plan matured, corresponding to 40% of the Units envisaged in the plan (57.327 Units, equal to 57.327 WIIT shares), unlisted shares with the ISIN code: IT0004922826.

The new composition of the share capital (underwritten and paid-in) is shown following the vesting of the Units and the consequent issue of n. 57.327 WIIT shares.
