### **Borsa Italiana orders the admission to listing of WIIT ordinary shares on the MTA**

### **The application for admission to trading on the MTA was presented to Borsa Italiana**

Milan, 25th March 2019 - WIIT S.p.A. ("WIIT" or the "Company"), one of the leading Italian players in the market of Cloud Computing services for businesses with a focus on the delivery of continuous Hybrid Cloud and Hosted Private Cloud services for critical applications announces that today, Borsa Italiana has ordered, with provision n. 8543, the admission to listing of the ordinary WIIT shares ("**Shares**") on the Mercato Telematico Azionario, a regulated market organized and managed by Borsa Italiana S.p.A. ("**MTA**"), and their simultaneous exclusion from the AIM Italia market.

Also today, the Company has submitted to Borsa Italiana the application for admission to trading of the Shares on the MTA and, based on the assumptions, on the STAR segment. The effectiveness of the Borsa Italiana provision is subject to the publication of the Information Prospectus.

The start of trading of the Shares on the MTA and, based on the assumptions, on the STAR segment, as well as their simultaneous exclusion from trading on the AIM Italia market will be established by Borsa Italiana with subsequent notice, subject to the publication of the Information Prospectus. WIIT is assisted by Intermonte and Advance SIM as Sponsor. Pedersoli Studio Legale acts as legal advisor to WIIT, while DLA Piper acts as legal advisor to the Sponsors. Deloitte is the auditing company and Studio Pirola Pennuto Zei is the tax consultant.
