The Secure Private Cloud solution, featuring migration of mission-critical core systems, including SAP, covers Disaster Recovery services and advanced perimeter protection for a total value of €2.8 million.

This is complemented by cybersecurity services and perimeter security solutions managed by WIIT, integrated into the client’s protection processes to ensure continuous and centralised control of the entire infrastructure.

To support growth requirements, the operational model will ensure high scalability on demand, whilst maintaining the capacity for evolution in line with the Customer’s digital transformation roadmap and long-term strategic objectives.
